For the health and safety of all, we request that you keep all of your animals, including well behaved dogs and cats in a safe out of the way place.

Please allow enough parking for our van and trailer in front of your event. If no space is provided the extra set up time may come off your party's time.

Please be sure that there is good access to your house, we will not drive down narrow driveways that do not have adequate room for a truck and trailer. We will not drive up or down steep driveways. No refund will be given on parties that have inadequate access.

Pony-Up operators and handlers will NOT carry petting zoo animals long distances or up steep driveways to set up. In cases of inadequate access Pony-Up reserves the right to leave petting zoo animals in the trailer for customers to enjoy there.

Our Ponies can be worked on grass, tarmac, blacktop or cement. They CANNOT work on heavily graveled surfaces.

Please choose a place where our ponies will have some shade during long parties (more than 2 hours). Please let us know IN ADVANCE if shade is not available so we can bring a cover for them

During very hot weather we MUST be able to park close enough to your home and have a hose available to us to give the animals water and for the misters on the trailer

We accept CASH only on the day of the event, if no cash is available for payment Pony-Up reserves the right to cancel party and no refund will be given on deposits.

Please be aware that parties 2 hours and longer will allow for breaks for the ponies and the handlers, we will have ponies going the whole time and you will receive all that you paid for.
